## **Appendix A: Definition Comparison**



## 1 Introduction

This report forms part of the Whitby Zoning By-law Review Study, a comprehensive phased undertaking that sets out to update Whitby's existing zoning by-laws into a new single Comprehensive Zoning By-law for the Town. The overall intent of the Zoning By-law Review Study is to create a new zoning by-law that will implement the Official Plan, that is clear, concise and easy to read and that provides necessary land use and built form direction while being flexible in implementation where appropriate.

Following separate Residential, Commercial, Mixed Use, Employment and Other Zone Reports, the objective of this report is to review and evaluate the definitions included in the Town of Whitby's zoning by-laws. The undertaking includes a review of the definitions within existing Zoning By-Law #1784 ("1784"), Zoning By-Law #2585 ("2585") and the Oak Ridges Moraine Zoning By-Law #5581-05 ("5581-05").

The purpose of this report is to understand and outline how the Town's current zoning definitions are organized and structured within each zoning by-law. The definitions reviewed in this report will assist in determining what definitions are required to interpret the provisions in Whitby's new Comprehensive Zoning By-law.

**Section 2** of this report explains where definitions are found in the existing zoning bylaws.

**Section 3** of this report includes a comparison table of the existing definitions across the three by-laws and provides a high level description and summary of the key findings

**Section 4** identifies definitions in the Official Plan which may be relevant to the zoning by-law.

**Section 5** explains the next steps in the Study.



# **2** Structure of Definitions in Existing Zoning By-Laws

#### 2.1 **Zoning By-law 1784**

Definitions are found in both their own section (Section 2) within Zoning By-law 1784, as well as in site specific exceptions in section (Section 12).

In addition to the definitions in Section 2, Zoning By-law 1784 contains subsections for the Village of Brooklin Central Core Area (Section 13) and the West Whitby Secondary Plan Area (Section 14), each of which contain additional definitions which apply to these areas.

## 2.2 **Zoning By-law 2585**

Similar to Zoning By-law 1784, Zoning By-law 2585 also includes definitions in a list in the definitions section (Section 2) as well as sometimes in the site specific exceptions.

Zoning By-law 2585 also contains a subsection for the Downtown Secondary Plan area (Section 26) which contains additional definitions that apply in this area.

## 2.3 **Zoning By-law 5581-05**

In the Oak Ridges Moraine Zoning By-law #5581-05, defined terms are only found in the definitions section (Section 3).



# **3** Comparison of Existing Definitions

The comparison of existing definitions was undertaken using two tables.

The table in **Appendix A** compares and analyzes each definition. Where multiple definitions for each defined term are found in the various zoning by-laws and site specific exceptions, it lists each of the different versions of the definition. The table includes definitions found in each zoning by-law's Definition Section, those found in the special areas, including the Downtown, Brooklin and West Whitby and in the site specific exceptions.

The table then provides recommendations on the existing definitions.

Based on our previous zoning by-law review experience and best practices noted in other contemporary zoning by-laws, the following considerations were used to review the definitions and prepare recommendations:

- Common terms do not need to be defined, especially where a typical dictionary definition appropriately captures the intent;
- The definitions should be easy to read and understand;
- · Terms that are no longer relevant can be deleted;
- Terms that are not used in the zoning by-law do not need to be defined;
- Simplicity and flexibility can be achieved by not over defining uses, for example, in defining very specific uses that can be captured by "retail store";
- Definitions should not regulate a matter or contain numerical regulations; and
- Definitions should not be located in site specific exceptions; they should apply comprehensively in the by-law.

This table forms only the initial analysis of appropriate definitions. As the project moves forward, this list of definitions will shift to align with those required to interpret the by-law as it is written, ensuring that new definitions are added, as needed, and those not used in the by-law are deleted.

**Tables 1, 2, 3 and 4** list the recommendations for each definition, based on the following categories:

• **Carry Forward:** One of the existing definitions is to be brought forward into the new zoning by-law.



- Carry Forward with Edits: One of the existing definitions is to be brought forward, with some revisions as noted in Appendix A.
- Consider Further: The need for the definition or further review of the appropriate wording of the definition will be considered in more detail in Phase 2 of this Study.
- **Delete:** The definition is no longer needed and is recommended to be deleted.

A majority of the definitions in the current Zoning By-laws are recommended to be carried forward. The remaining definitions in the existing Zoning By-laws are outdated and require revision, no longer apply and will need to be deleted or have to be considered further in Phase 2 of the study. Some of the current definitions also contain regulations that are not applicable and will have to be revised accordingly.

In Phase 2, for the definitions where further consideration is needed, a best practice review to inform how other municipalities have addressed these will be undertaken.



## 4

## **Official Plan**

The definitions in the Official Plan were also reviewed to ensure consistency between the two documents and identify any additional definitions that should be carried forward into the zoning by-law.

Two definitions in the Official Plan are recommended to be used in the zoning by-law.

- The definition of Accessory Use which reads, "The use of any land, building, or structure which is normally incidental to, subordinate to, and exclusively devoted to, the principal use located on the same lot."
  - The Official Plan definition is the clearest compared to the existing zoning definitions as it refers to a "use of a building, structure, or lot".
- The definition of home industry reads: "Small-scale industrial use, primarily serving the agricultural community, which is an accessory use to a farm or rural residential lot, and includes such uses as carpentry, metalworking, welding, electrical work or blacksmithing, but shall not include auto repair or paint shop or furniture stripping."

This definition should be included in the zoning by-law.



# **5** Next Steps

The purpose of this report is to identify and summarize the definitions and differences between multiple definitions for the same term. The report explores how terms are defined, how they should be revised or carried forward and where these definitions are found in each of the current zoning by-laws.

This information will ensure that Whitby's new Comprehensive Zoning By-law, can be properly interpreted.

As the study considers the uses and provisions required in the new Comprehensive Zoning By-law, in Phase 2 of the Study, other additional definitions may be identified or the recommended definitions further refined. In addition, as part of Phase 2, a best practice review of how other municipalities' address the difficult definitions that require further consideration will occur.
